



FULL REGISTRATION CONTRACT FOR A PET PUPPY

Thank you for purchasing one of our Golden Retrievers. We strive to breed and raise quality puppies and dogs. We fell in love with this breed 29 years ago and long to be a part of producing not only quality but healthy and sound puppies. This agreement is made and entered into, by and between (seller) Elite White Goldens and Buyer _____, for the purpose of setting forth the terms and conditions of purchase by the Buyer of a purebred golden retriever puppy from the litter _____ whelped on _____, out of Sire _____ and Dam _____.

The buyer agrees to purchase a male / female puppy, with Full Registration, from the litter described above subject to the following terms... Puppy will come with LIMITED AKC REGISTRATION UNTIL THE COMPLETION OF PASSING HEALTH TESTING AT AGE 2. PUPPY CAN NOT BE BRED UNTIL THE TESTING IS COMPLETED AND CAN ONLY BE BRED TO A PASSING HEALTH TESTED MALE. 1 PUPPY FROM HER BREEDING CAN HAVE FULL REGISTRATION FOR THE BREEDER ONLY. THE REMAINING OFFSPRING OF THIS FEMALES BREEDINGS WILL NOT BE ENTITLED TO FULL REGISTRATION BUT BE SOLD WITH ONLY LIMITED REGISTRATION. All puppies must participate in a 6 week long Obedience Class, with an actual trainer, by the age of 5 months old. A \$500 nonrefundable deposit is required to get on each litter waiting list. A replacement puppy will be given of equal quality from a upcoming litter.

1. Seller warrants that the above puppy is a purebred golden retriever, can be registered with the AKC and that registration papers:

- have not
- have been
- will be provided

to the Buyer as of the date of the completed purchase as well as the option to obtain a true copy of its pedigree. The AKC Registration form will be sent to you when we receive them. Said puppy comes with a LIFETIME genetic health guarantee and a 1 year on Hips, Elbow, Eyes and Heart that results in death or OFA Disqualification. All OFA testing is to be completed on said puppy prior to breeding or health guarantee is null and void. Breeder will require verification of testing prior to breeding.

2. Seller warrants that the above-described puppy is in good health at the time buyer assumes ownership. Buyer agrees to have the puppy examined by a licensed Veterinarian within three (3) days (not including weekends and holidays) of receipt of puppy. If, as a result of the examination, the Veterinarian determines the puppy is not in good health (excluding worms, giardia, coccidia and fleas as these are common and can be picked up anywhere), then the Buyer shall elect to keep the puppy or return the puppy. If the Buyer elects to return the puppy, Buyer shall be obligated to return the puppy to sellers immediately (within the 2 days) at the Buyers expense. Buyer shall, email Seller immediately within 2 days after Veterinary Exam and within the 3 days after date of pick up, send to Seller by Certified Mail a Written Veterinarians Certificate stating that the puppy was in ill health when examined. Upon receipt by Seller of said Certificate Buyer will be given the opportunity to pick a replacement puppy from the available puppies or a future litter. All action taken to return the puppy shall be done with the best interest of the puppy in mind including the temperature at time of shipment, non-stop flights at Buyers expense.

3. Reasonable precautions shall be taken by Buyer to prevent and acquire any hereditary faults. No treadmilling, Jogging, standing on back legs or excessive ball chasing or retrieving should be done with this puppy/dog prior to 2 years of age. No hard exercise, rough playing, or extensive running with adults, children or other animals should be allowed. Restrict the puppy's activities to sensible activities (brief short walks) and discourage jumping activities. Owners understand that extended and exhaustive playing with older dogs or forced exercise can actually cause joint and bone problems because of soft tissue development, until the age of two years. If said puppy/dog develops hip dysplasia, determined by the Orthopedic Foundation for Animals Inc to be lower than Fair resulting in the refusal by OFA to issue a certificate between 24-36 months from date of birth, the Buyer may return the dog to Seller and will receive a replacement puppy of like quality from the next available litter, or may keep the dog, which will be spayed or neutered, and Seller will refund \$200 upon proof of sterilization. If Buyer chooses a replacement puppy, Buyer and Seller shall make prompt arrangements within 7 business days of receipt of Certified Letter and Veterinarian Certification of OFA report and x-rays, for return of the puppy sold herein to Sellers place of Business. Buyer shall be responsible for taking good and reasonable care of the puppy until Seller receives it. Cost and related expenses of returning the puppy to Seller shall be the obligation of the Buyer. In the unlikely event that a dog is suspected of being dysplastic in the first two years, this is the procedure to follow:

- Notify us by telephone, email or letter.
- The dog must be x-rayed for this condition BEFORE its second birthday but not before 1.5 years old.
- Submit the x-ray to the OFA.

- Dog MUST NEVER HAVE BEEN USED FOR BREEDING. Must not be overweight and is during its growth period. After 1 year of age, the dog should be still with the original owner.
- No replacement will be given if the dog has been over exercised. Puppy/dog must be kept at a weight acceptable for the breed. After 1 years of age dog should not exceed 65-75# for females and 75-85# for males.

4. Ownership of the puppy will be transferred to the Buyer for the sale price of _____.

5. If long distance delivery is requested by Buyer, it shall be by airfreight, to a designated location. Buyer will pay all shipping fees. Including in shipping fee: cost of crate, insurance during shipment, cost of freight charges plus handling, health certificate as well as other items deemed necessary by Seller.

6. The Seller has determined that the puppy is of "BREEDING quality" and it can be used for breeding.

7. The Seller agrees to refund to Buyer the sum of \$200-upon receipt of evidence from Licensed Veterinarian that the puppy/dog has been spayed or neutered.

8. Puppy will carry the Elite White Goldens kennel name as a prefix when registering.

9. Buyer agrees he or she is not acting as agent in the purchase of this puppy and the Buyer will not sell this puppy or it progeny to any agent, pet store or guard dog business.

10. Buyer agrees if it becomes necessary to otherwise sell or dispose of this puppy, Buyer will notify Seller before taking such action so that puppy may, at Seller's option, be returned to Seller. Upon notification, the Seller shall have 15 working days to exercise said return option. Exercise shall be notice in writing sent to Buyer and phone calls.

11. Buyer agrees that the puppy will reside at the home of the Buyer, have access to fenced yard, not be chained or tethered, and will be provided with proper housing, a good quality diet, annual shots and exercise. Buyer also agrees that this puppy/dog will not be used as a guard dog for any business. Buyer agrees at least one basic obedience class will be completed with this puppy/dog.

12. This guarantee will be null and void if Buyer does not supply the dog with NuVet Plus for Canines on a daily basis. Buyer is required to use NuVet Labs on a daily basis, during and after the guarantee period, failure to do so will make this guarantee null and void.
